

ABSTRACT

This thesis entitled "The Law of Succession
Under the Civil Code and the Muslim Code of the Philippines: A Comparative Study" explains in detail, compares and contrasts, the law of succession under the Civil Code of the Philippines which is called for short as the Civil Code and the law of succession under the Code of Muslim Personal Laws of the Philippines which is called for short as the Muslim Code.

The law of succession under the Civil Code is considered in detail with the pertinent provisions of the Civil Code, the rulings of the Supreme Court of the Philippines, and the standard treatises in Civil Law.

Similarly, the law of succession under the Muslim Code is considered in detail with the pertinent provisions of the Muslim Code, the Muslim law as found in the Holy Qur'an, Hadith, standard treatises on Muslim law, pertinent rulings in the applications of Muslim law, and modern Muslim legislations.

This study explains, compares and contrasts, the law of succession under the Civil Code and the Mus-

lim Code for better understanding and seeks to identify their weaknesses for possible modification or amendment for their growth and development.
