## **ABSTRACT**

The thesis discusses the causes of divorce and its effects on the family in light of the Prophetic method; it relies on what is stated in the Sunnah of the Prophet (P.b.u.h.), in specifying the reasons of divorces and their consequences on the family and society at large. The thesis also describes all the conditions that ought to be present in divorce, and highlights the practical aspects employed by the Prophet (P.b.u.h.) in dealing with cases of divorce. Additionally, it also examines the practical aspects of the companions (may Allah be pleased with them) and their successors in adjudicating divorce cases. The thesis illustrates how the prophetic method can be applied in the present time, and uses descriptive, analytical and historical approaches in developing its evidence. The thesis concludes that the prophetic method is a comprehensive approach that has relevance even today.
